## ARTICLES OF INCORPORATION OF WEST COAST KIRKPLAN KITCHENS, INC

#### ARTICLE I

Name. The name of this corporation is WEST COAST KIRKPLAN KITCHENS, INC.

#### ARTICLE II

Duration. The corporation shall be perpetual.
