ARTICLES OF INCORPORATION OF TEDDY RANDAZZO MUSIC, INC.

The undersigned, acting as Incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I-NAME

The name of the corporation shall be TEDDY RANDAZZO MUSIC, INC.

ARTICLE II-PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 5254 Oak Island Road, Orlando, Florida 32809.

ARTICLE III-DATE OF EXISTENCE

This corporation shall exist perpetually, commencing on the date of execution of these Articles of Incorporation.
