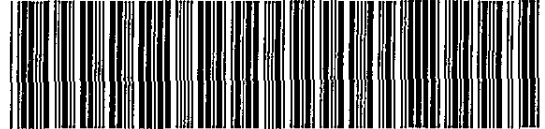

**ARTICLES OF INCORPORATION
OF
SBD TRADEMARK, INC.**

ARTICLE I - NAME

The name of this corporation is SBD TRADEMARK, INC. (the "Corporation").

ARTICLE II - PRINCIPAL OFFICE

The principal office of the Corporation is located at the following address:
