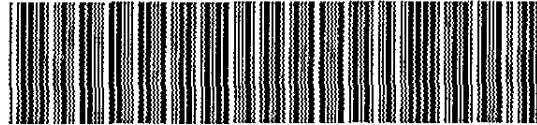

The name of this corporation is MARK BROWN OF MARION COUNTY

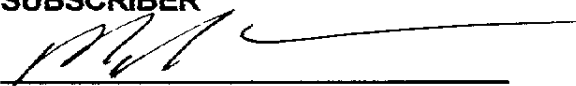
