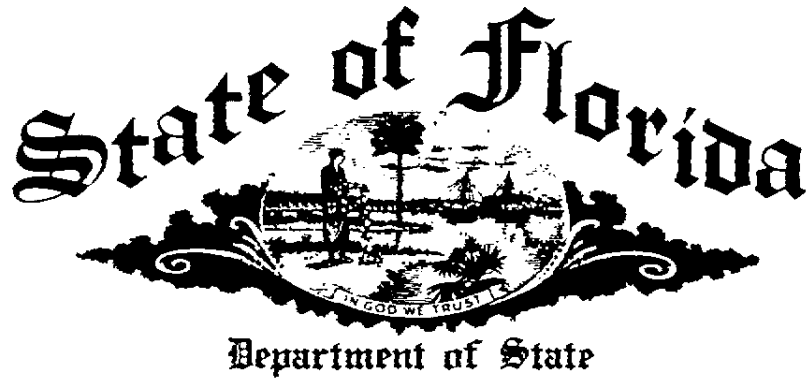


CERTIFICATE OF ADMINISTRATIVE DISSOLUTION
