#### ARTICLES OF INCORPORATION

#### FOR

## FRESH BREAD, INC.

#### Article I.

## Corporate Name

The name of this corporation is Fresh Bread, Inc.

#### Article II.

# Nature of Business and Powers

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

## Article III.

#### Term of Existence

This Corporation shall have perpetual existence commencing upon filing of these Articles of Incorporation.

## Article IV.

## Capital Stock

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is Ten Thousand (10,000) shares of common stock having no par value.

## Article V.

# Registered Agent and Initial Registered and Principal Office
