**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
SHUTTER SOLUTIONS OF CENTRAL FLORIDA, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, Shutter Solutions of Central Florida, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Shutter Solutions of Central Florida, Inc.
2. Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

"ARTICLE I - NAME

The name of the Corporation is: Shutters, Blinds & More, Inc (the "Corporation")."

3. The foregoing amendment was approved by the Board of Directors of the Corporation by Unanimous Written Consent on March 23, 2006, and it was recommended that the Articles of Amendment be presented to the Shareholder for adoption at a special meeting.

4. The foregoing amendment was adopted pursuant to Section 607.1003, Florida Statutes, by Written Consent of the sole Shareholder on March 23, 2006; the vote of the sole Shareholder for the amendment was sufficient for approval.
