Article I.

The name of this corporation is Gladiators Soccer Club Academy, Inc.

Article II.

Nature of Business and Powers

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III.

Term of Existence

This Corporation shall have perpetual existence commencing upon filing of these Articles of Incorporation.

Article IV.

Capital Stock

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is One Thousand (1,000) shares of common stock having no par value.

Article V.

Registered Agent and Initial Registered and Principal Office

The name of the initial registered agent and the street address of the initial registered office and principal office of this Corporation in the State of Florida shall be: Rafael Quintin, 804

Initial Directors

The person(s) named as initial directors shall hold office for the first year of existence of this Corporation or until their successor(s) is/are elected or appointed and has/have qualified, whichever occurs first.

Article X.

Amendment

These Articles of Incorporation may be amended in the manner provided by law. certain amendment of these Articles of Incorporation be made.




