

ARTICLE I. NAME

The name of this corporation is
HI-TECH COMPOSITES INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

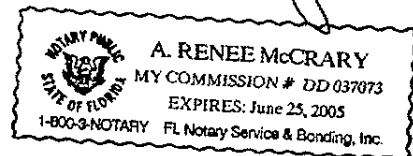


