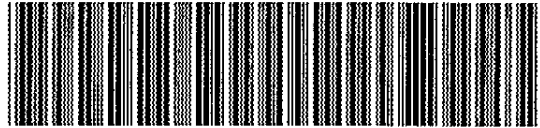

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby associates himself to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is

The nature of the business:

1. Hair salon and spa, with sales of related products and services.
2. Any and all legal business or businesses.

ARTICLE III

Capital Stock:


ARTICLE XI
