ARTICLES OF INCORPORATION

of

D.C. HELICOPTERS, INC.

The undersigned Incorporator for the purpose of forming a corporation under Chapter 607, Florida Statutes, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME AND ADDRESS

The name of this corporation is D.C. HELICOPTERS, INC. The principal place of business of the corporation is 539 Baywood Drive South, Dunedin, Florida 34688.

ARTICLE II - DURATION

The duration of the corporation is perpetual.
