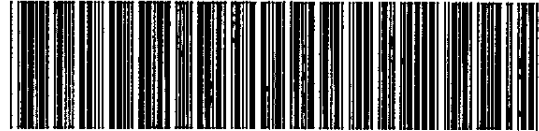

## **ARTICLE IX**


