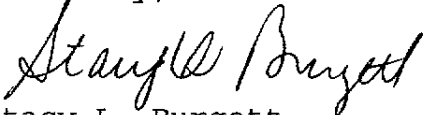

Article I - Name

The name of this corporation is VK REAL ESTATE, INC., and its principal office is located at 6099 N. Atlantic Ave., Cape Canaveral, FL 32920.

Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these Articles are filed with the Secretary of State.

Article III - Purpose

Article X - Indemnification

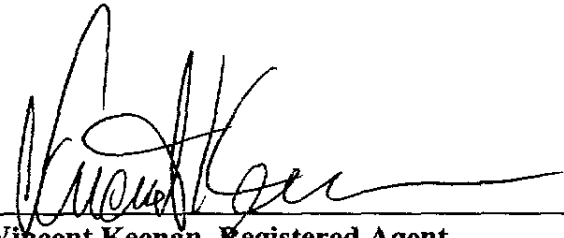
The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

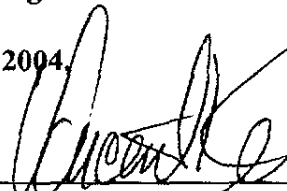
Article XII - Acceptance of Registered Agent

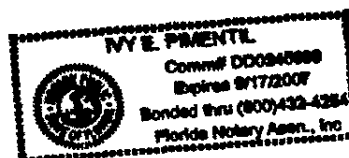
