ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be OCALA EUCHRE, INC., with its principal place of business at 1051 Southeast 52nd Court, Ocala, Florida 34471.
