#### ARTICLES OF INCORPORATION

of

#### EDAHL, INC.

I, ERIC C. DAHL, the undersigned, do hereby associate myself for the purpose of forming and becoming a corporation for profit, under the laws of the State of Florida, and do hereby certify that they have become such corporation under and pursuant to the following Articles of Incorporation.

## **ARTICLE I - NAME**

The name of this corporation is:

## **ARTICLE II - NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is as follows:

- To engage in the business to lease rent, mortgage, buy and sell aircraft, in accordance with FAA Regulations.
- 2. To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease, rent or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses in the State of Florida and in all other states and countries.

To acquire, by purchase, lease, manufacture or otherwise, any personal property deemed necessary or useful in the equipment, furnishings, improvement, development or management of any property, real or personal, at any time owned, held, or occupied by the corporation, and to invest, trade, and deal in any personal property deemed beneficial to the corporation, and to lease, rent, encumber or dispose of any personal property at any time owned or held by this corporation.
