
ARTICLE VIII

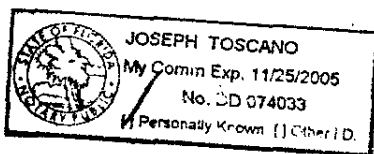


