#### X. AMENDMENTS

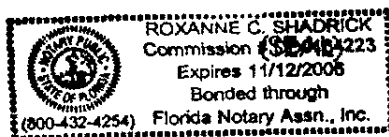


