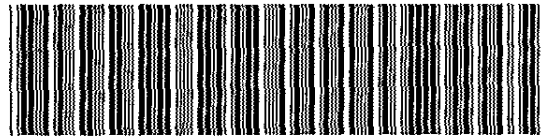

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME


ARTICLE IX - BY LAWS
