OF

CSHIV HOLDINGS, INC.

I, the undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, do hereby engage and commit myself in and to the formation of CSHIV HOLDINGS, INC. under the laws of the State of Florida pursuant to the provisions of Chapter 607, Florida Statutes.
