

ARTICLES OF INCORPORATION OF VICTORIA'S SKIN CARE, INC.

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

Article 1. Name.

The name of the Corporation is: VICTORIA'S SKIN CARE, INC.

Article 2. Duration.

The duration of the Corporation is perpetual.

Article 3. Purpose.
