

ARTICLES OF INCORPORATION

OF

The undersigned natural person, competent and licensed to Practice in the state of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida General Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation shall be:

the principle place of business of this corporation shall be 8649 North Himes Avenue, #3812, Tampa, Fl 33614

ARTICLE II. NATURE OF BUSINESS

The general nature and purpose of this business to be transacted, promoted and carried on by the corporation are as follows:

- A. To engage in every aspect in the practice of real estate, and all its fields of specialization's, as are engaged by real estate professionals,
- B. To engage and render the professional services involved only through its officers, agents and employees who shall be real estate professionals in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.
