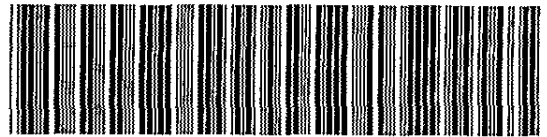

ARTICLES OF INCORPORATION  
OF  
LOCKLER INSTALLATIONS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby associates himself to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is Lockler Installations, Inc.

ARTICLE II

The corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III

The corporation may engage in any activities or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

The initial post office address of the principal office of this corporation in the State of Florida is 2602 West Kirby Street, Tampa, FL 33614. The Board of Directors may from time to time move the registered office to any other address in Florida.

ARTICLE V

The name and address of the incorporator signing these Articles is Jeffrey F. Lockler, 2602 West Kirby Street, Tampa, FL 33614.

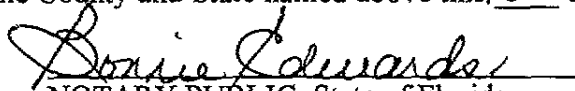

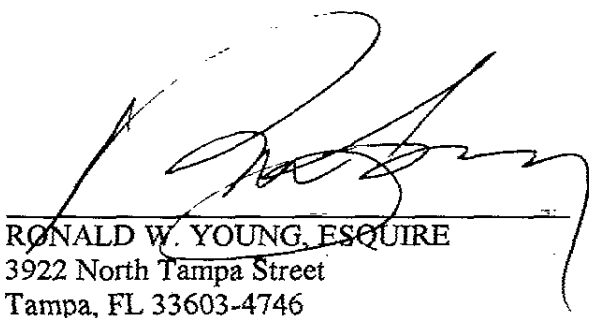
