

ARTICLES OF INCORPORATION

OF

ANDERSON COURT REPORTING SERVICE, INC.

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME:

The name of this Corporation is:

ANDERSON COURT REPORTING SERVICE, INC.

ARTICLE II

PURPOSES AND POWER:

The general nature of business to be transacted by this Corporation is as follows:

1. The Corporation may engage in any activity of business which is permitted under the laws of the State of Florida.
2. And in general, to carry on any other business whatsoever in connection with the foregoing or which is calculated, directly or indirectly, to promote the interest of the Corporation or to enhance the value of its properties.
3. And further, to borrow or raise money for any purpose of the Corporation, and to secure the same interest, or for other purposes, to mortgage all or part of the property, corporeal or incorporeal rights or franchise of this Corporation now owned or hereinafter acquired, and to create, issue, draw, and accept and negotiate bonds and mortgages, bills of exchange, promissory notes or other obligations or negotiable instruments.

ARTICLE III

CAPITALIZATION:

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE HUNDRED (100) shares of common stock, having a par value of ONE and NO/100 (\$1.00) DOLLAR per share.

ARTICLE IV
INITIAL CAPITAL:

The amount of capital with which this Corporation will begin business is ONE HUNDRED (\$100.00) DOLLARS.

ARTICLE V
COMMENCEMENT AND DURATION:

This Corporation shall commence its existence immediately upon the filing of these Articles of Incorporation, pursuant to Section 607.167, Florida Statutes, and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE VI
INITIAL PRINCIPAL OFFICE:


