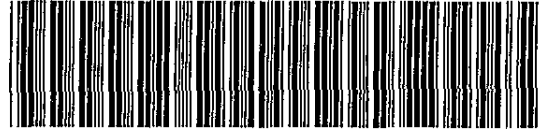

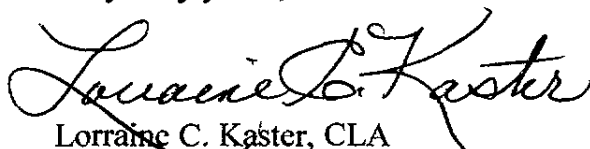

ARTICLE I - Name

The name of the corporation is: **SOUTHEAST KENPO KARATE ACADEMY, INC.**

ARTICLE II - Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

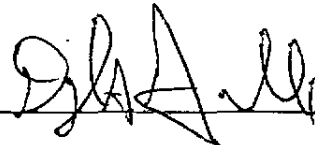

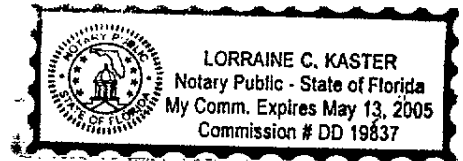
