ARTICLE XI. AMENDMENT

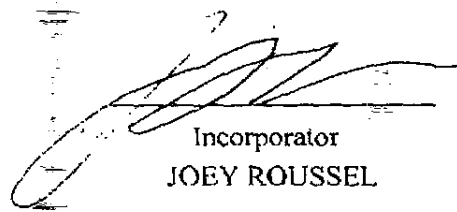

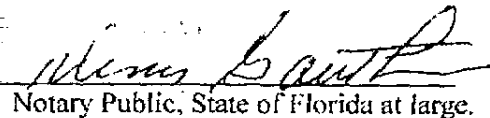

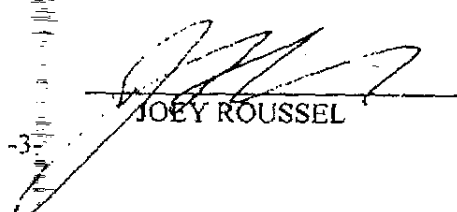
