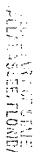

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

## ARTICLE I

#### **CORPORATE NAME**

The name of the corporation shall be ROBERT T. POLLAK, P.A.

#### **ARTICLE II**

## **DURATION**

This corporation shall have perpetual existence, commencing on the date of filing of these Articles.

#### ARTICLE III

# **INITIAL PRINCIPAL OFFICE**

The initial principal office of this corporation shall be located at Castlewood at Imperial, 1789 Supreme Court, Naples, Fl 34110.

## ARTICLE IV

## **PURPOSE**

The corporation is organized for the purpose of real estate sales services to the public.

#### ARTICLE V

#### CAPITAL STOCK

The corporation is authorized to issue 7500 shares of 1.00 par value common stock, which shall be designated "common shares". The stock of this corporation is intended to qualify under the requirements of Section 1244 of the Internal Revenue Code and regulations issued thereunder. Every shareholder, upon the sale for cash of any new stock of the corporation of the same kind, class, or series as that which he holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

## ARTICLE VII

#### INITIAL REGISTERED OFFICE AND AGENT
