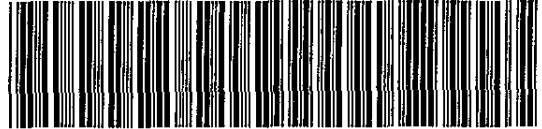

The undersigned, for the purpose of forming a for-profit corporation under the Florida General Corporation Act and the provisions for professional associations thereunder hereby adopts the following Articles of Incorporation.

**ARTICLE ONE
NAME**

The name of the Corporation is **Zakia Healing Solutions, P.A.**.

**ARTICLE TWO
DURATION**

The term of existence of the Corporation is perpetual.

**ARTICLE THREE
PURPOSE**

The purpose for which the Corporation is formed is to engage in the healing treatment of members of the public by acupuncture, and such ancillary functions as may enhance or make such treatment more efficacious, all within the scope of Chapter 457, Florida Statutes.

**ARTICLE FOUR
CAPITAL STOCK**
