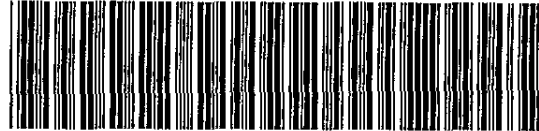

ARTICLES OF INCORPORATION  
OF  
PRESSED FOR TIME OF THE PALM BEACHES, INC.  
ARTICLE I—NAME

The name of this corporation is PRESSED FOR TIME OF THE PALM BEACHES, INC. and its principal place of business shall be located at 1301 13th Way, West Palm Beach, Florida 33407.

ARTICLE II—DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III—PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as a general business corporation.

ARTICLE IV—CAPITAL STOCK

This corporation is authorized to issue three hundred (300) shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

ARTICLE V—PRE-EMPTIVE RIGHTS

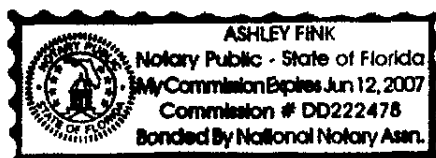

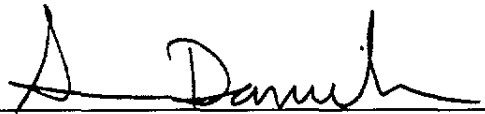
