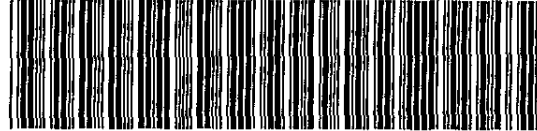



**ARTICLE I- NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is **FLORIDA IMAGE REMODELING, INC.** and its principal place of business shall be located at **606 Lime Street, Auburndale, FL 33823**

**ARTICLE II- DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III-PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV- CAPITAL STOCK**

This corporation is authorized to issue **100** shares of common stock, with an assigned value of \$1.00 per share and shall designated as ACommon Shares.
