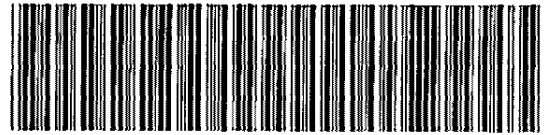


Previously, we mailed you a Corporate name change Amendment and we forgot to include the check to pay for the fee and certified copy.
