

**ARTICLES OF INCORPORATION
OF
MOVING WITH PRIDE, INC.**

ARTICLE I - NAME

The name of this corporation is MOVING WITH PRIDE, INC. The principal place of business of this corporation shall be 100 North Broadway, Englewood, Florida, 34223 (P.O. Box 593402, Orlando, Florida, 32859).

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may hereafter be amended.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of One Cent (\$.01) par value common stock which shall be designated as "Common Shares."

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional

shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 100 North Broadway, Englewood, Florida, 34223, and the name of the initial registered agent of this corporation at that address is SHAWN M. DOERING. The principal office is the same as for the registered agent. The mailing address for the registered agent is P.O. Box 593402, Orlando, Florida, 32859.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have One Director constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaws; however, there shall never be less than one Director.

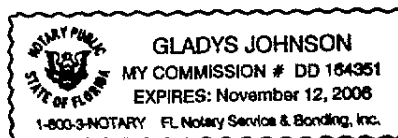
