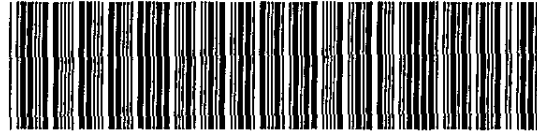

ARTICLE I - NAME

The name of this corporation is: BENNIE MCDUFFIE GOOD FAITH  
CONTRACTING, INC.

ARTICLE II - DURATION

The corporation shall exist perpetually commencing on the date of filing.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transaction any or all lawful  
business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common  
stock.

ARTICLE V - PRE-EMPTIVE RIGHTS

It is the intention of this charter that the directors shall sell the capital stock of this corporation in accordance with the conditions of Section 1242-1244, inclusive, of the Internal Revenue Code.

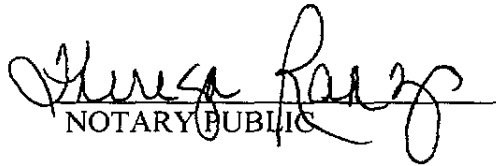

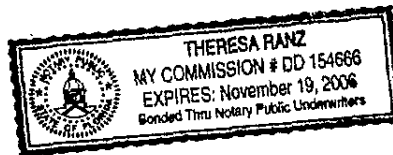
