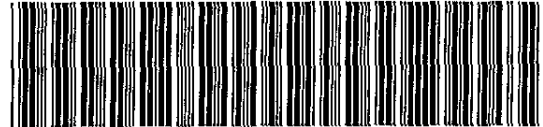

**ARTICLE I  
NAME**

The name of the corporation shall be: Maribel Sabia Insurance, Inc.

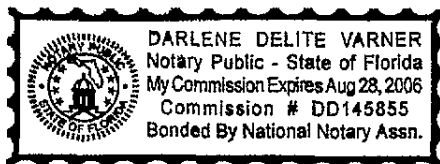
