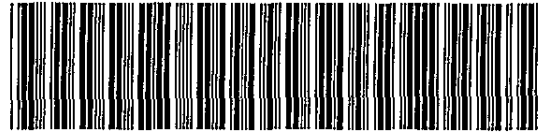
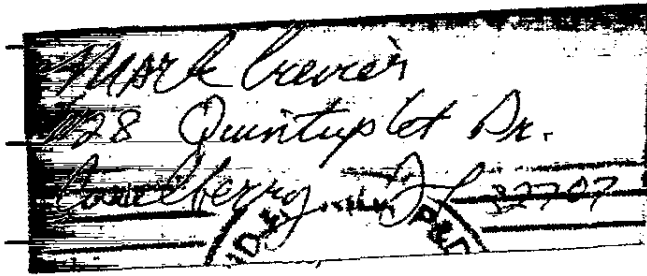

ARTICLES OF INCORPORATION
OF

The following Articles of Incorporation are made pursuant to the "Florida Professional Service Corporation Act", *Florida Statute 621*, as amended.

NAME AND PRINCIPAL OFFICE OF CORPORATION

The name of this corporation is MARK CREVIER CONSTRUCTION, INC., and the principal address and initial office of the corporation is 1128 Quintuplet Drive, Casselberry, Florida 32707.

AUTHORIZED SHARES

Unless and until these Articles are amended, there shall be one (1) class of stock. The stock shall be common stock and the corporation shall be authorized to issue five hundred (500) shares of such stock, each share having a par value of \$.10.
