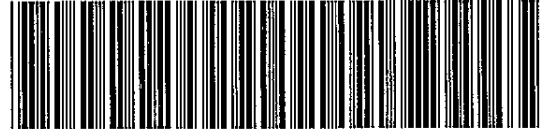




**ARTICLE VIII PRE-EMPTIVE RIGHTS**


**ARTICLE VIII INDEMNIFICATION**
