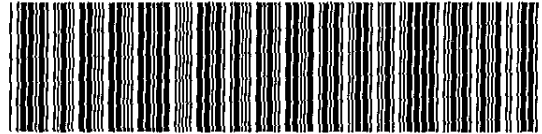

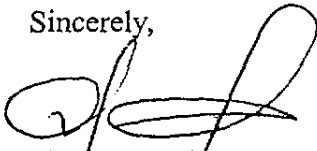

The corporation's shall be existence perpetually.

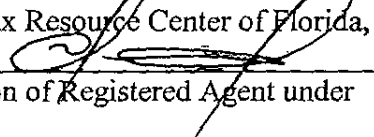
Article III - Purpose

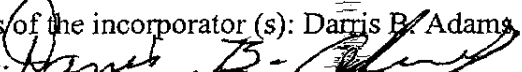
Article IV - Authorized Capital
