

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Omni Inspections, Inc.

ARTICLE II - PRINCIPAL OFFICE ____

The mailing address of this corporation shall be: 5433 N.W. 55th Terrace Coconut Creek, Florida 33073

ARTICLE III - PURPOSE

This corporation is organized for the purpose transacting any or all lawful business.
