The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the Corporation is MAJESTIC INTERNATIONAL, Inc. Principal place of business is C/O Jack Milbery, CPA, PA, 150 S. University Drive, Suite F Plantation, FL 33324.

**ARTICLE II: DURATION**
