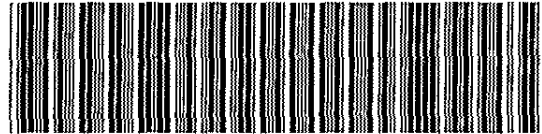

ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation is: **T & M CONCRETE, INC.**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The purpose of this corporation is to provide service for the construction of concrete foundations for residential and commercial structures and any and all other lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

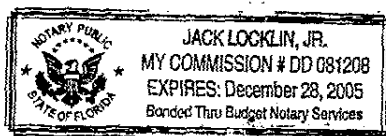




