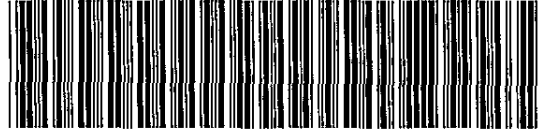

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE I

The name of the Corporation is GAINESVILLE AUTO GLASS, INC.

The duration of the corporation is perpetual.

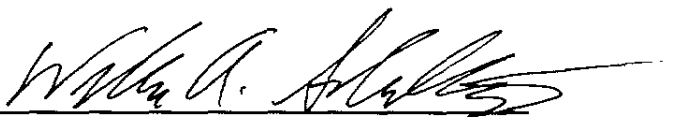
