ARTICLES OF INCORPORATION OF PASO FINOS DE ROLLINGWOOD, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME & ADDRESS

The name of this Corporation is PASO FINOS DE ROLLINGWOOD, INC. The principal office, if known, or the mailing address of the Corporation is 21829 ROLLINGWOOD TRAIL, EUSTIS, FLORIDA 32736.

ARTICLE II - DURATION
