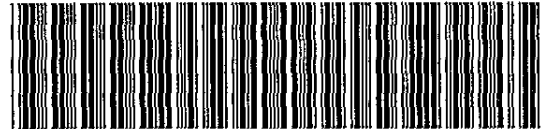



ARTICLE I. CORPORATE NAME

The name of this corporation is **GRAPHIC PRODUX CORPORATION**.






