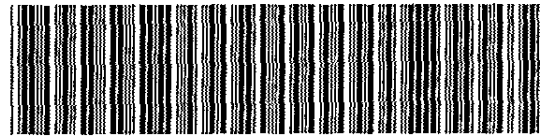

**Article I – Name**

The name of this corporation is: G.S.O. DEVELOPMENT, INC.

**Article II – Duration**

This corporation shall have perpetual existence.

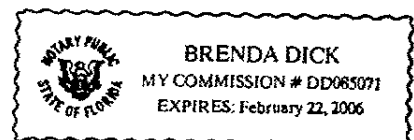

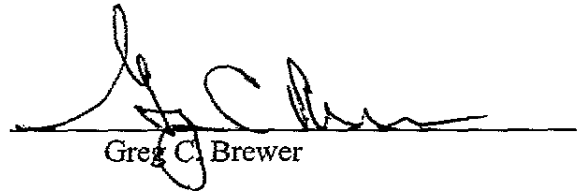
