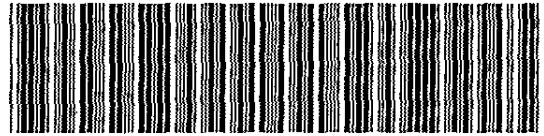

The name of this corporation is: LOSEHIN Investment, Inc.

ARTICLE II. NATURE OF BUSINESS
