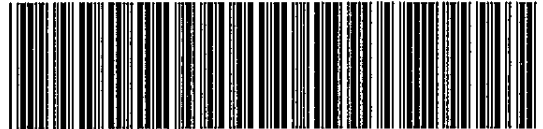



ARTICLE I - Name

The name of the corporation is:

ARTICLE II - Mailing Address

ARTICLE III - Capital Stock

The corporation is authorized to issue one million (1,000,000) shares of common stock, \$.01 par value.
