

ARTICLE I. CORPORATE NAME.

The name of this Corporation is Joyner Landclearing, Inc. .

ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE.

ARTICLE VIII. BOARD OF DIRECTORS.

This Corporation shall have three directors initially. The number of directors may be increased from time to time by By-laws adopted by the stockholders, but shall never be less than one.

ARTICLE IX. INITIAL DIRECTORS AND OFFICERS.




ARTICLE X. AMENDMENT.
