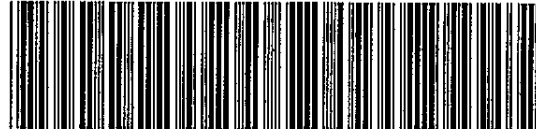

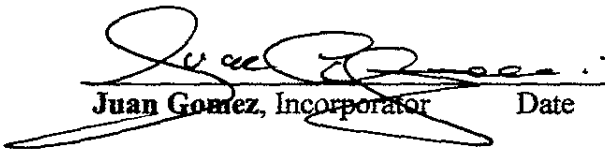
ARTICLE VIII- AMENDMENTS
