ARTICLES OF INCORPORATION

OF

QUICKLUBE SERVICES, INC.



The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I: NAME

The name of the corporation is Quicklube Services, Inc.

ARTICLE II: DURATION

The corporation is to commence its corporate existence on the date of filing of the Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III: PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV: STATED CAPITAL

The corporation is authorized to issue 100,000 shares of common at ONE 00/100 (\$1.00) par value common stock. Each outstanding share, regardless of class, shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.

The shares of stock may be issued for such consideration, having not less that the par value of the shares issued therefor, as is determined from time to time by the board of directors, to be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation. Shares may not be issued until the full amount of the consideration therefor has been paid. Thereafter, such shares shall be deemed to be fully paid and non-assessable.

ARTICLE V: BOARD OF DIRECTORS

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the board of directors.

Any and all of the powers and duties conferred to or imposed upon the board of directors, by resolution of the shareholders adopted at a special meeting called for that purpose, may be exercised or performed to such extent and by such person or persons as shall be provided by the shareholders.

The corporation shall have THREE directors initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation.
