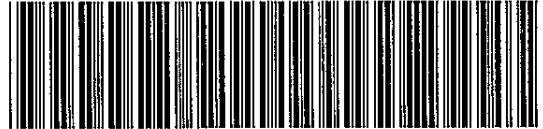

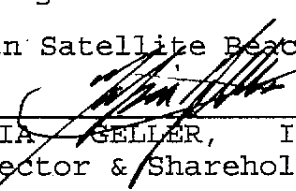
The Director and Shareholders wish to accept the resignation of NAKIA GELLER as a President of the Corporation.
