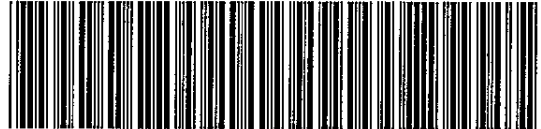

NAME

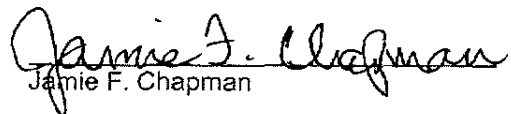
